During the 2017-2018 school year, the Communities In Schools of Mid-America network provided services in 50 schools, helping more than 35,000 students accomplish their goals and achieve real results. And these successes were achieved by students with documented risk in each of the categories in which they were tracked. Those successes included: *99% of students tracked as potential dropouts remained in school at the end of the year; *96% of students tracked as eligible Seniors for graduation successfully received their high school diplomas; *94% of students tracked for promotion risk were promoted to the next grade; *83% of students tracked for needing to improve their behavior met their improvement goals; *80% of students tracked for needing to improve their attendance met their improvement

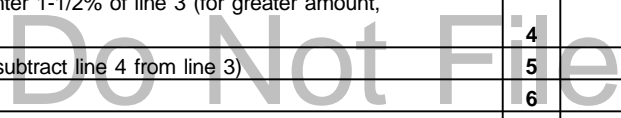
