During the 2018-19 school year, CIS of Mid-America provided services in 52 schools, serving more than 37,000 students. Student achievement among case-managed students included the following outcomes: 98% of students remained in school, reducing the instances of drop-out; 93% of students were promoted to the next grade, reducing student retention rates; 93% of seniors graduated; 73% of students with attendance risk factors and goals improved in attendance; 87% of students with school behavior risk factors and goals improved in school behavior; and, 81% of students needing academic progress improved in academic achievement.
