During the 2019-2020 school year, CIS of Mid-America provided services in 56 schools, serving more than 36,000 students. Student achievement among case-managed students included the following outcomes: 99% of students remained in school, reducing the instances of drop-out; 96% of students were promoted to the next grade, reducing student retention rates; 95% of seniors graduated; 73% of students with attendance risk factors and goals improved in attendance; 87% of students with school behavior risk factors and goals improved in school behavior; and, 80% of students needing academic progress improved in academic achievement.
